## Limited number of ISDN lines offered to employees with data needs

Internal Communications has a limited number of Integrated Services Digital Network (ISDN) lines available to employees who have data as well as voice needs.

Ameritech ISDN is used to transmit and receive digitized voice and high speed data simultaneously over an ordinary twisted-pair telephone line. The most common application for employees is to use one ISDN channel for normal voice activities while using another channel for data transmissions such as elec-mail. For users with greater data needs, the second channel may be used for high speed circuit switched data.

Employees will be considered for an ISDN line if they meet the following criteria:

 Have a work telephone number in the 312 area code with a "727" or "220" prefix.

 Have proper authorization to purchase the ISDN CPE required. The price range for the CPE is between \$700 and \$800.

 Have proper authorization to cover the appropriate installation cross charges involved.

If you meet the above criteria and are interested in signing up for ISDN service, just complete and return a 309 Request for Service Review - Voice-Data/Facsimile Form. These forms are available on AOS. Include on the form that you are requesting one of the ISDN lines offered in Bulletin # 17. The form should be sent to the Internal Communications group on HQ 12 E.

## **Companywide inventory begins June 1**

Beginning June 1, 1993, Illinois Bell will conduct a comprehensive inventory of data communications equipment including mainframe and personal computers, and company communications equipment, (i.e. terminals, terminal controllers, printers, modems, ISDN terminals, etc.).

responsible for locating, identifying, and bar-coding more than 60,000 computer and company communications equipment items in approximately 300 company locations throughout the state. The inventory of communications equipment is necessary to better manage any additional spending for new equipment by reassigning unused equipment to other employees and to comply with Federal Communications Commission accounting guidelines.

Each organization has been assigned a Departmental Coordinator who will work with ACR, Inc. to ensure each employee's work location is properly inventoried.
